DEMOCRATIC PARTY

Instructions to Voter

To vote for a person (except governor and lieutenant governor) whose name is printed on the ballot, darken the oval to the left of the person's name.

To vote for persons for governor and lieutenant governor whose names are printed on the ballot, darken the oval to the left of the pair of persons running together for such office.

To vote for a person whose name is not printed on the ballot, write the person's name in the blank space, if any is provided and darken the oval to the left of the person's name.

If you tear, deface or make a mistake and wrongfully mark any ballot, you must return it to the election board and receive a new ballot.
