REVIEW OF THE MEETING MINUTES:

- **Welcome New Board Members:** The board members provided introductions and Welcomed Captain John Grosko to the board.

RESUMED BUSINESS:

- **Revision/Approval on the FY 2017 Quarterly Budget Adjustment Report:**
Mr. Lockman mentioned this document was the final adjustment of the end of year funds for 4th Quarter of FY 2017. Some end of the year funding was made available by moving a position (COG) to tax dollars, thus allowing more money for substance abuse treatment; registration; Drug Court Staff-Client Defense; and Drug Testing Supplies.

- **Update:**

Mr. Lockman provided the board members an update of probationer's success rate for completing probation and not entering the prison system. The Kansas Department of Corrections gave all Community Corrections Departments a goal of 75% success rate of completing probation. To date our Department has hit the 75%.

Mr. Lockman also stated the Juvenile Department has also hit a mile stone. No youth were in group homes last Friday. The Juvenile numbers are going down every year. Mr. Lockman also mentioned minor crimes are going down every year.

Judge Russell stated the Behavioral Health Court is on target to start in the month of September 2017. Judge Lampson is in the process of hiring attorneys for the court. Mr. Lockman mentioned training will start soon for pre-trial, court services, community corrections, Wyandotte County Mental Health, and the Crisis Team.
