**UNIFIED GOVERNMENT OF WYANDOTTE COUNTY/KANSAS CITY, KANSAS  
Substantial Amendment #1 to the 2019 Annual Action Plan**

The Unified Government of Wyandotte County/Kansas City, Kansas (UG) is required by federal regulation and regulatory waivers to publish and provide a 5-day citizen review and public comment period for Substantial Amendment #1 to the 2019 Annual Action Plan. The citizen review and public comment period will commence on July 9, 2020. This Substantial Amendment incorporates three (3) allocations of supplemental funding for HUD entitlement grants: Community Development Block Grant CV1 (CDBG-CV1) (\$1,355,838), Emergency Solution Grants CV1 (ESG-CV1) (\$683,879) and ESG-CV2 (\$1,707,698) provided to HUD by the CARES Act to prevent, prepare for and respond to COVID-19.
