**COVID-19 RULES ARE REQUIRED PHASE 3**

No more than 45 people allowed at the sale at any-given-time and enforced by those holding the sale.  
Social distancing at least 6 feet must be maintained, at-all-times and enforced by those holding the sale.  
Those interacting to handle money for the sale must, properly wear a mask, at-all-times.  
All others at the sale are encouraged to properly wear a mask.

**ARTICLE IV. GARAGE SALES**

**Sec. 19-78. - Definitions.**

The following words, terms and phrases, when used in this article, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

*Garage sale* means a sale operated out of a single-family, dual-family, or multiple-family dwelling or such dwelling's porch or yard or any sales from a private residence.

*Goods* includes any goods, wares, merchandise or other property capable of being the object of a garage sale.

**Sec. 19-79. - License.**

Any person wishing to conduct or participate in conducting a garage sale shall obtain a license from the license administrator upon payment of a fee in the amount established by the county administrator.

**Sec. 19-80. - Number of sales.**

It shall be unlawful for any person to conduct or be an agent for any other person or have any financial interest in more than two garage sales within the city within one year last past from the date of the person's current garage sale.

**Sec. 19-81. - Nature of goods.**

It shall be unlawful for any person to sell at a garage sale goods that have been purchased for resale or that are not the property of the seller.

**Sec. 19-82. - Time limits.**

It shall be unlawful for any person to conduct a garage sale lasting longer than a period of three days; provided, however, that the license administrator may extend the time for good cause and upon payment of the fee established by the county administrator.
