BRIEF JOB DESCRIPTION: Responsibilities include operating all equipment associated with landscaping; aerify turf areas, applying herbicides, pesticides as directed. Monitor irrigation systems, drives snowplows and sanders during snow removal. Operates all equipment incidentals to landscaping. Applies granular materials with tractor drawn spreader. Plants, waters, fertilize mulch and maintain shrubs, flowers, trees and turf. Prune, trim and remove shrubs, trees and stumps and other related duties as required. Obtains prices for materials and supplies, fills out paperwork as required. Removes all trash and debris as directed. Must have a valid Kansas CDL with appropriate endorsements or must obtain one within 90 days.

MINIMUM QUALIFICATIONS: High School Diploma or GED, Valid Kansas CDL license with appropriate endorsements or ability to obtain one within 90 days. Ability to follow oral and written instructions.
