BRIEF JOB DESCRIPTION: Responsible for transporting individuals in a safe and efficient manner throughout the community. Transit programs include: Fixed Route transit, ADA and Senior Paratransit and transportation for several Aging services, including Meals on Wheels. Must be able to work well with the general public, maintain records, have good communication and writing skills, work different shifts and overtime, including holidays and/or weekends.

MINIMUM QUALIFICATIONS: High School Diploma or GED required. May either possess a valid Kansas Commercial Driver's License (CDL) license or permit, with passenger endorsement and DOT Certification preferred; or the ability to obtain a Class C or higher CDL License and passenger endorsement within 6 months of hire; must be 21 years of age and good driving record for the past three (3) years. Must possess proof of current liability insurance in at least the minimum amount required by Kansas law. This position typically requires driving, sitting, bending, balancing, stooping, kneeling, crouching, reaching, standing, walking, pushing, pulling, lifting, talking, hearing, seeing, and repetitive motion and may require long periods of sitting while driving. May require walking and standing for long periods of time. May require very heavy work, exerting in excess of 100 pounds of force occasionally, and/or in excess of 50 pounds of force frequently, and/or in excess of 20 pounds of force constantly to move objects. Ability to pass a physical agility test, motor vehicle records search, criminal background check and drug screening (All test conducted and paid for by the Unified Government as part of the application process).
