**BRIEF JOB DESCRIPTION:** This skilled position is responsible for inspections, plan review, issuing permits, and recording data for residential and commercial permit applications. Plans, materials and workmanship are inspected and/or reviewed for compliance with city codes and ordinances regulating construction, alteration, installation, and repair of buildings, building appurtenances, building systems, including electrical, plumbing, mechanical systems and equipment. Good communication skills when working with the public, property owners, contractors and design professionals at the building inspection service counter and in the course of conducting an inspection.

**MINIMUM QUALIFICATIONS:** High School Diploma or GED and considerable experience in the building, mechanical, electrical, and plumbing trades at the full-skilled crafts level; or any equivalent combination of education and experience which provides necessary skills and knowledge. Knowledge of construction principles and practices application to residential and commercial buildings. Applicants should have the ability to read and interpret construction documents. Effective written and oral communication skills are essential. Ability to work independently performing plan reviews or field inspections and must make decisions requiring independent judgment; however technical advice and assistance are available from supervisors on difficult or unusual cases. Ability to establish and maintain working relationships with design professionals, contractors and the public. The ability to deal effectively with individuals involved in the construction field is preferred. A valid driver's license is required at time of application, a mvr check will be conducted.
