**BRIEF JOB DESCRIPTION:** The Public Health Department of the Unified Government of Wyandotte County/ Kansas City Kansas is seeking a full time Registered Dietitian to work in our clinical services area and within the community providing nutrition education programming. Duties include but are not limited to the following: assess the health and dietary needs of clinic patients and community members, screen for, and provide nutrition education for those at an increased risk for the development of chronic illnesses (i.e. type two diabetes, hypertension, heart disease, etc.), provide individual nutrition counseling, breastfeeding, registering prenatal clients for Women Infants and Children (WIC) services, providing prenatal nutrition education classes.

**MINIMUM QUALIFICATIONS:** Bachelor's Degree in Nutrition and two years of dietary experience; or, any equivalent combination of education and experience sufficient to successfully perform the essential duties of the job. Must be a registered Dietitian (or eligible) and a licensed Dietitian in Kansas (or eligible). Must have the ability to work in a busy clinic setting with a diverse client population. Bilingual in English/Spanish is a plus. 40-hour workweek Monday through Friday includes occasional Thursday evening clinic. Must reside in Wyandotte County or relocate within 12 months.
