Construction

Divided into three subsectors

233, Building, Developing, and General Contracting, building construction, land subdivision and land development

234, Heavy construction (except buildings), such as highways, power plants, and pipelines. Usually assume responsibility for an entire construction project

235, Special Trade Contractors, are primarily engaged in specialized construction activities under subcontract or directly for project owners.

233 Building, Developing, and General Contracting

Primarily responsible for the entire construction (i.e., new work, additions, alterations, and repair) of building projects. Builders, developers, and general contractors, as well as land sub-dividers and land developers are included in this subsector. The construction work may be for others and performed by custom builders, general contractors, design builders, engineer-constructors, joint-venture contractors, and turnkey contractors, or may be on their own account for sale and performed by speculative or operative builders.

2331 Land Subdivision and Land Development

Primarily engaged in subdividing real property into lots and/or developing building lots for sale.

2332 General Residential Building Construction

23321 Single Family Housing Construction

Primarily responsible for the entire construction (i.e., new work, additions, alterations, and repairs) of single family residential housing units (e.g., single family detached houses, town houses, or row houses). Includes establishments responsible for additions and alterations to mobile homes and on-site assembly of modular and prefabricated houses. May perform work for others or on their own account for sale as speculative or operative builders.

23322 Multifamily Housing Construction

Primarily responsible for the entire construction (i.e., new work, additions, alterations, and repairs) of multifamily residential housing units (e.g., highrise, garden, and town house apartments).

2333 General Nonresidential Building Construction

233310 Manufacturing and Industrial Building Construction

Primarily responsible for the entire construction (i.e., new work, additions, alterations, and repairs) of manufacturing and industrial buildings (e.g., plants, mills, factories).

233320 Commercial and Institutional Building Construction

Primarily responsible for the entire construction (i.e., new work, additions, alterations, and repairs) of commercial and institutional buildings (e.g., stores, schools, hospitals, office buildings, public warehouses).

Examples:

Bank, Church, Cinema, Hospital, Hotel, Office building, Warehouse, Restaurant, School, Shopping center

234 Heavy Construction

Engage in the construction of heavy engineering and industrial projects (except buildings), for example, highways, power plants, and pipelines. May include new work, reconstruction, or repairs. Usually assume responsibility for entire non-building projects but may subcontract some or all of the actual construction work. **Special trade contractors are included in this group if they are engaged in activities primarily related to heavy construction, for example, grading for highways.**

2341 Highway, Street, Bridge, and Tunnel Construction

234110 Highway and Street Construction

(1) establishments **primarily responsible for** the entire construction (i.e., new work, reconstruction, or repairs) of highways (except elevated), streets, roads, or airport runways; (2) establishments identified as highway and street construction management firms; and (3) establishments identified as special trade contractors engaged in performing subcontract work primarily related to highway and street construction (e.g., grading for highways, installing guardrails, public sidewalk construction). Establishments may subcontract some or all of the actual construction work.

234120 Bridge and Tunnel Construction

(1) establishments **primarily responsible for** the entire construction (i.e., new work, reconstruction, or repairs) of bridges, viaducts, elevated highways, and tunnels; (2) establishments identified as bridge and tunnel construction management firms; and (3) establishments identified as special trade contractors primarily engaged in performing subcontract work related to bridge and tunnel construction. Establishments may subcontract some or all of the actual construction work.

2349 Other Heavy Construction

234910 Water, Sewer, and Pipeline Construction

(1) establishments **primarily responsible for** the entire construction (i.e., new work, reconstruction, rehabilitation, or repairs) of water mains, sewers, drains, gas mains, natural gas pumping stations, and gas and oil pipelines; (2) establishments identified as water, sewer, and pipeline construction management firms; and (3) establishments identified as special trade contractors engaged in activities primarily related to water, sewer, and pipeline construction. Establishments may subcontract some or all of the actual construction work.

234920 Power and Communication Transmission Line Construction

(1) establishments **primarily responsible for** the entire construction (i.e., new work, reconstruction, or repairs) of electric power and communication transmission lines and towers, radio and television transmitting/receiving towers (2) establishments identified as power and communication transmission line construction management firms; and (3) establishments identified as special trade contractors engaged in activities primarily related to power and communication transmission line construction. Establishments may subcontract some or all of the actual construction work.

234930 Industrial Non-Building Structure Construction

(1) establishments **primarily responsible for** the entire construction (i.e., new work, reconstruction, or repairs) of heavy industrial non-building structures, such as chemical complexes or facilities, cement plants, petroleum refineries, industrial incinerators, ovens, kilns, power plants (except hydroelectric plants), and nuclear reactor containment structures; (2) establishments identified as industrial non-building construction management firms; and (3) establishments identified as special trade contractors engaged in activities primarily related to industrial non-building construction. Establishments may subcontract some or all of the actual construction work.

234990 All Other Heavy Construction

(1) establishments **primarily responsible for** the entire construction (i.e., new work, reconstruction, or repairs) of heavy non-building construction projects (except highway, street, bridge, tunnel, water lines, sewer lines, pipelines, power and communication transmission lines, and industrial non-building structures); (2) establishments identified as all other heavy construction management firms; (3) establishments primarily engaged in construction equipment rental with an operator; and (4) establishments identified as special trade contractors engaged in activities related primarily to all other heavy construction. Typical projects include athletic fields, dams, dikes, docks, drainage projects, golf courses, harbors, parks, reservoirs, canals, sewage treatment plants, water treatment plants, hydroelectric plants, subways, and other mass transit projects. Establishments may subcontract some or all of the actual construction work.

235 Special Trade Contractors

Engage in specialized construction activities. Usually perform most of their work at the job site, although they may have shops where they perform prefabrication and other work.

2351 Plumbing, Heating, and Air-Conditioning Contractors

235100 Non Plumbing Installation and Service

Primarily engaged in one or more of the following: (1) Boilermaker services (2) Fire Sprinkler Systems (3) Lawn Sprinkler Systems (4) Septic Systems. Includes new work, additions, alterations, and maintenance and repairs.

235110 Plumbing, Heating, and Air-Conditioning Contractors

Primarily engaged in one or more of the following: (1) installing plumbing, heating, and air-conditioning equipment; (2) servicing plumbing, heating, and air-conditioning equipment; and (3) the combined activity of selling and installing plumbing, heating, and air-conditioning equipment. Includes new work, additions, alterations, and maintenance and repairs. The activities range from duct fabrication and installation at the site to installation of refrigeration equipment, and installation of environmental controls.

2352 Painting and Wall Covering Contractors

235210 Painting and Wall Covering Contractors

Primarily engaged in interior or exterior painting and interior wall covering. Includes new work, additions, alterations, and maintenance and repairs. Activities range from bridge, ship, and traffic lane painting to paint and wall covering removal.

2353 Electrical and Wiring Contractors

235300 Wiring Contractors (LOW LEVEL)

Primarily engaged in one or more of the following: (1) installing wiring (2) the combined activity of selling and installing wiring & equipment. Includes new work, additions, alterations, and maintenance and repairs.

Examples: (Alarm System, Computer cable, Fiber optic cable, Telecommunication equipment)

235310 Electrical Contractors

Primarily engaged in one or more of the following: (1) performing electrical work at the site (2) servicing electrical equipment at the site; and (3) the combined activity of selling and installing electrical equipment. Includes new work, additions, alterations, and maintenance and repairs.

Examples: (Electrical construction, Electrical repair, Lighting system construction)

2354 Masonry, Drywall, Insulation, and Tile Contractors

235410 Masonry and Stone Contractors

Primarily engaged in masonry work, stone setting, and other stone work. Includes new work, additions, alterations, and maintenance and repairs. Activities range from foundations made of block, stone, or brick to glass block laying; exterior marble, granite and slate work; and tuck pointing.

235420 Drywall, Plastering, Acoustical, and Insulation Contractors

Primarily engaged in drywall, plaster work, acoustical, and building insulation work. Includes new work, additions, alterations, and maintenance and repairs. Plaster work includes applying plain or ornamental plaster, including installation of lathing to receive plaster.

Examples: (Acoustical paneling, Ceiling, Drywall, Plastering (plain or ornamental), Soundproofing)

235430 Tile, Marble, Terrazzo, and Mosaic Contractors

Primarily engaged in (1) setting and installing ceramic tile, marble (interior only), terrazzo, and mosaic and/or (2) mixing marble particles and cement to make terrazzo at the job site. Includes new work, additions, alterations, and maintenance and repairs.

2355 Carpentry and Floor Contractors

235510 Carpentry Contractors

Primarily engaged in framing, carpentry, and finishing work. Includes new work, additions, alterations, and maintenance and repairs. Activities range from the installation of doors and windows to paneling, steel framing work, and ship joinery.

235520 Floor Laying and Other Floor Contractors

Primarily engaged in the installation of resilient floor tile, carpeting, linoleum, and wood or resilient flooring. Includes new work, additions, alterations, and maintenance and repairs.

2356 Roofing, Siding, and Sheet Metal Contractors

235600 Siding, and Sheet Metal Contractors (NO ROOFING)

Primarily engaged in the installation of siding, sheet metal, and drainage-related work, such as downspouts and gutters; and treatment (spraying, painting, or coating), copper or tin smithing, installing skylights, metal ceilings, flashing, duct work, and capping. Includes new work, additions, alterations, and maintenance and repairs.

235610 Roofing, Siding, and Sheet Metal Contractors

Primarily engaged in the installation of roofing, siding, sheet metal work, and roof drainage-related work, such as downspouts and gutters; and roof treatment (spraying, painting, or coating), copper or tin smithing, installing skylights, metal ceilings, flashing, duct work, and capping. Includes new work, additions, alterations, and maintenance and repairs.

2357 Concrete and Asphalt Contractors**235710 Concrete Contractors**

Primarily engaged in the use of concrete and asphalt to produce parking areas, building foundations, structures, and retaining walls, and in the use of all materials to produce patios, private driveways, and private walks. Includes new work, additions, alterations, and maintenance and repairs.

2358 Water Well Drilling Contractors**235810 Water Well Drilling Contractors**

Primarily engaged in drilling, tapping, and capping of water wells, and geothermal drilling. Includes new work, servicing, and maintenance and repairs.

2359 Miscellaneous Special Trade Contractors**235910 Structural Steel Erection Contractors**

Primarily engaged in one or more of the following: (1) erecting metal, structural steel, and similar products, (2) setting rods, bars, rebar, mesh, and cages, to reinforce; and (3) erecting cooling towers and metal storage tanks. Includes new work, additions, alterations, reconstruction, maintenance and repairs.

235920 Glass and Glazing Contractors

Primarily engaged in installing glass (i.e., glazing work) and/or tinting glass. Includes new work, additions, alterations, maintenance and repairs.

235930 Excavation Contractors

Primarily engaged in preparing land for building construction. Activities performed by these establishments are drilling shafts, foundation digging, foundation drilling, and grading. Includes new work, additions, alterations, and repairs.

235940 Wrecking and Demolition Contractors

Primarily engaged in the wrecking and demolition of buildings and other structures, including underground tank removal, and dismantling of steel oil tanks; (except those for hazardous materials). May or may not sell materials derived from demolishing operations.

235950 Building Equipment and Machinery Installation Contractors

Primarily engaged in one or more of the following: (1) installation or dismantling of building equipment, machinery or other industrial equipment (except plumbing, heating, air conditioning or electrical equipment); (2) machine rigging; and (3) millwrighting. Types of equipment installed include automated and revolving doors, conveyor systems, dumbwaiters, dust collecting equipment, elevators, small incinerators, pneumatic tubes systems, and built-in vacuum cleaning systems. Includes new work, additions, alterations, and maintenance and repairs.

235990 All Other Special Trade Contractors

Primarily engaged in specialized construction work. **Activities include** constructing swimming pools, fences, house moving, waterproofing, dewatering, damp-proofing, fireproofing, sandblasting; installing antennas, artificial turf, awnings, countertops, fire escapes, forms for poured concrete, gasoline pumps, lightning conductors, ornamental metal, shoring systems and specialized activities, such as bathtub refinishing, coating and glazing of concrete surfaces, gas leakage detection, insulation of pipes and boilers, mobile home site setup and tie-down, posthole digging, radon remediation, scaffolding work, and on-site welding. Includes new work, additions, alterations, and maintenance and repairs.
