




- The State of Kansas is comprised of 105 counties with each being a separate appraisal district.
- These counties determine the appraised value of property located in their jurisdiction for ad valorem tax purposes.
- The counties of Wyandotte, Douglas, Johnson, Sedgwick, and Shawnee are historically the largest contributors to the appraised and assessed property valuation for the state.



Total of All Appraised Property


Wyandotte County contributed 3.7 percent or \$7.06 billion in property valuation to the state's appraised value. This total includes residential, commercial, and personal property values.





Total of All Assessed Real Property

Wyandotte County contributed 3.8 percent or \$1.065 billion of the state's assessed real property value.



Total of All Assessed Residential Real Property


Wyandotte County contributed 3.2 percent or \$529.9 million of the state's assessed residential property value.





Total of All Assessed Commercial Real Property


Wyandotte County contributed 6.2 percent or \$513.1 million of the state's assessed commercial real property value.





Total of All Assessed Personal Property


Wyandotte County contributed 4.7 percent or \$64.5 million of the state's assessed personal property value.

Wyandotte County contributed 2.2 percent or \$91.7 million of the state's assessed public utilities property value.


