Karen Greenwood – commission voted for Safe and Welcoming and it was a very long meeting, next step find 3rd party to create municipal ID – state Atty General challenging S&W and is asking Legislature to pass legislation against this kind of ordinance.

The bill is HB 2171`7, Federal and State Affairs Committee, they want to make the ordinance null and void and prohibit future initiatives, make municipal ID requirements more stringent. The bill is still in committee and we are hoping it will fly under the radar.

This ordinance has been signed into local law and Karen said ACHRDI voted to support and sent letter to commission and our next step is to promote the municipal ID.

Conversion Therapy Ban – Christian thanked Tom for being strong advocate and talked about how Tom presented the proposal to Christian before he ran for office. Christian said it took 2 years to bring it forward, reluctance by the previous may and he took it to Garner upon his and election and Garner supported it. Christian worked with legal and shared with ACHRDI and wqent through committee and placed on consent agenda.

After Safe and Welcoming was approved, the conversion therapy ban was pulled by other commissioners- don't know why-community needs to be more educated.
