- I. Call to Order -5:44 PM When quorum was achieved
- II. Approval of minutes from August meeting Karen Greenwood moved for approval, Don Jolley seconded, Minutes Approved

- D. Conviction Integrity Unit Kendall McReynolds office is ready, up and running. Need to hire the part-time lawyer and part-time investigator. Everything is separate from the DA's office. Motto is "Minister of Justice." First one in the State of Kansas. Kansas Statute 1507 established the opportunity for the review of cases. We need to invite him to speak to our group sometime after the first of the year.

- A. Municipal ID Initiative Karen Greenwood Alex Martinez of ACLU spoke at our unofficial September meeting. He would like to come speak again when we have a quorum. 1 in 5 residents of Wyandotte County do not have ID. They live on the edge. Logistics can be an issue. Law enforcement across the country supports municipal IDs. Questions about the minimum criteria for an ID. The UG will have to decide what the program looks like. Karen will check into Alex's schedule.
- B. Sponsor documentary Jessie Alvarez Referring to the documentary about women soldiers discussed above. Is this something we could do to as an outreach effort? Kendall moved that we sponsor the screening of the documentary of "Journey to Normal." Tom seconded (and volunteered to help) suggestion was made that we work with the library. Motion Passed. Karen also volunteered to help.

- D. Other New Business
 - 1. Jessie wanted to mention that we are supposed to be doing an annual report. Phyllis reported to the commission as part of the Administrator's Annual Report. Phyllis will look into this further.
 - 2. Kendall talked about Sustained Traumatic Stress Reaction experienced especially by children in distressed living conditions. This may be something we need to look into. Kendall will do some more research. Perhaps the DA could also address this when he comes.
 - 3. Tom has been working on the Mobile Market Community Council—Food desert many areas don't have access to grocery stores. They have a converted a beer truck to be a mobile market. 15 sites have been selected. It will be rolling out soon.
 - 4. Tom spoke about diabetes education in the community. KSU did a diabetes program through Extension Office. Tom contacted KSU Extension about helping them market the program. Lori Wuellner is supposed to contact him.
 - 5. Tom has been doing some follow-up on our NDO work. Checking out the anti-bullying programs in the schools. All four districts have one, but not sure how well enforced. There were a number of other areas that we need to check into. Do we need a sub-committee to look at raising our MEI (Municipality Equality Index)? Tom will send the report. A part of our score is that we didn't report everything.
