Reed Partridge reviewed the Wyandotte County 911 Fund Audit Police Department.

## BACKGROUND

The purpose of this audit was to review and report on the effectiveness of internal controls over Kansas City, Kansas Police Department (KCKPD) expenditures from the Wyandotte County 911 Fund (911 Fund). The audit also reports on KCKPD's compliance with statutes that make up the related Kansas 911 Act (Act).

### Kansas 911 Act

Kansas statutes K.S.A. 12-5362 through 12-5381 make up the Kansas 911 Act. The Act relates to 911 emergency services in Kansas. The Act provides for statewide monitoring and planning of 911 systems. The Act also sets the framework for the collection and distribution of fees used to support 911 communication systems across Kansas.

## 911 Coordinating Council

K.S.A. 12-5364 established the 911 Coordinating Council (Council). The Council has several responsibilities aimed at fulfilling the intent of the Act. Those responsibilities include monitoring the delivery of 911 services and developing statewide strategies for improvements to 911 communication systems. The implementation of Next Generation 911 (NG911) services is an example of the Council's strategy for improvement. Additionally, the Act charges the Council with the administrative responsibilities of collecting and distributing 911 fees. Further, the Council has authority to monitor the expenditure of 911 fees by cities and counties to ensure expenditures align with the intent of the Act.

### 911 Fees

K.S.A. 12-5369 and 12-5371 imposed fees on telecommunication subscriber accounts and prepaid wireless transactions respectively. Subscriber accounts consist of traditional land lines, wireless, VoIP and other telecommunication systems capable of contacting 911 services. Initially the Act set fees at \$0.53 per subscriber account per month. Beginning July 2019, the fee increases to \$0.90 per month.

Prepaid wireless fees are calculated by retail transaction. The fee applies to the purchase of cell phones preloaded with a set amount of minutes, the purchase of additional minutes and prepaid calling cards. Beginning July 2019 the rate will increase to 2.06% of the transaction. Table 1 presents 911 fee rates for subscriber accounts and prepaid wireless services.

### **Distribution of Subscriber Account 911 Fees**

K.S.A. 12-5374 outlines the distribution of fees collected based on population and fees generated by the county. For counties with a population over 80,000, such as Wyandotte, the Council distributes 82% of the fees collected within the county to the public safety answering point (PSAP) for the county. The Unified Government (UG) is the PSAP for Wyandotte County.

The 50% increase in subscriber account rate shown in Table 1 may not result in a corresponding increase in distributions to the county PSAP. July 2019 amendments to the Act include withholding \$0.23 of the subscriber account fee for deployment and maintenance of the statewide NG911 System. Another \$0.01 is to be withheld until the 911 State Grant Fund balance exceeds \$2 million. Therefore, the PSAP may only see its distribution based on \$0.66 of the \$0.90 subscriber account fee. # **AUDIT RESULTS**

This audit reviewed the effectiveness of internal controls over transactions related to the 911 Fund as well as compliance with applicable statutes. The audit consisted of testing of transactions and required reporting during the audit period for the following:

- Disbursements contained adequate supporting documentation, supervisory review and approval and were aligned with the intent of the authorizing statutes
- Fund revenues allocated by the state were received by the UG
- KCKPD fulfilled the statutory reporting requirements

In the areas tested we found no material instances of non-compliance related to attributes listed above.

# MANAGEMENT RESPONSE

The Police Department reviewed the report and agreed with the conclusions presented.

Chief Zeigler came into the meeting about 4:20 and announced his resignation. He said the department is in a good position at this time and he feel this is a good time for him to move to another chapter in his life. He has a business model and cannot reach out to his clients until he separates from the police force. He will separate on Sept 11 and his official date will be October 1. He hopes to do fundraising for the PAL program and stay connected to the community.

Chief Zeigler told the board about the shooting and subsequent standoff at 91 n mill street. The bad guy has shot at police officers and the snipers are ready to take him out if the opportunity presents itself. No officers were hurt so far but its believed that one female has been shot.
