INMATE HEALTHCARE

Right to healthcare for all persons in custody whether convicted or not.

- ✓ *Medical*
- ✓ *Dental*
- ✓ *Mental Health*

Includes Juveniles

The health care service provider is responsible for providing comprehensive health care services.

Every inmate goes through a medical screening upon intake.

Comprehensive health evaluations and assessments are performed within 14 days of intake and allow the health care provider to establish a plan of care, if necessary.

Other services include medical, dental and psychiatric care, vision and pharmacy.

The health care service provider also manages the hospitalization of inmates when necessary, the cost of eyeglasses or vision services and the cost of medical supplies.

The health care provider offers a daily sick call that allows inmates to be seen by a qualified healthcare professional. A sick call is for routine medical and dental needs that fall outside of an inmate's established plan of care. The inmate's commissary account is charged \$5.00 per sick call and deposited into the Jail Commissary Fund.

RECOMMENDATIONS

1. Wellpath should supply documentation of the required insurance coverage.
2. Ensure appropriate budgetary controls exist.
3. Monitor reinsurance claims. *Audit found claims due totaling \$38,988.*

They are looking to complete the new Juvenile Justice Center by the end of the year and will occupy the building by February.

There is a new job classification "Detention Correction Officers" to be used soon.

Chief Zeigler reported that they are short 41 positions as of today.

Chief Zeigler talked about the importance of the Cadet Program to reach out to the youth of the community in hopes they would choose law enforcement as a career path.

He said that the department would like to see the residency ordinance loosened to allow our recruiters to go outside of WYCO to fill those positions.
