- Survey will be developed and distributed throughout the process, allowing for continued gathering of voices.

Our desire is for the community to feel as free as possible to share, thus we recommend that law enforcement officials not attend the listening sessions. In addition, we recommend that law enforcement personnel be excused from the portion of our Reflect and Planning meetings when we are discussing what we have heard from the community. Our goal here is not to exclude law enforcement from the conversation, but to freely process what we have heard so that we may report accurately and advise accordingly.

Our hope is that out of this conversation we can fulfill our obligation to the community to advise on long-term policy solutions. We recognize, however, that there may arise the need for short-term, urgent responses concerning testimonies we may hear.

We request LEAB members to confirm attendance for the above dates with their commissioners.
