## Social Media Term of Use

The UG encourages and welcomes the public to engage in dialogue, share opinions, and provide feedback on social media sites managed by the UG. Please be aware that these sites are limited public forums and moderated by UG staff.

The UG reserves the right to limit, turn off or 'disable' comments should they deem it necessary for posts that are intended for one directional communication from the UG to the public; or in the instance a post exceeds 100 comments and/or cannot effectively be monitored.

All content on the UG's social media and all comments submitted to UG social media are public and subject to disclosure pursuant to the Kansas Open Records Act. <u>Please be aware that</u> anything you post may survive deletion.

All comments or postings related to the UG social media sites will be subject to monitoring by the Department of Strategic Communications.

The UG is committed to serving the online community in a civil and unbiased manner. To best facilitate online conversation, please keep your comments to the topic at hand. Users who submit posts or comments on UG social media sites agree that they have read, understand and agree to these terms of use and that the UG expressly reserves the right to remove or block submissions that contain:

- Profanity or vulgar and abusive language;
- Personal attacks or threats of any kind;
- Offensive comments that target or disparage any ethnic, racial, cultural, or religious groups, or other protected classes of people;
- Sexual content or links to sexual content;
- Sensitive information (i.e. information that could compromise public safety or ongoing investigations, or private information of individuals)
- Spam or links to other sites;
- Depictions or renditions advocating illegal activity;
- Advertisements promoting particular services or products, or endorsements of political organizations or candidates;
- Infringement on copyrights or trademarks;

For all UG social media sites, the UG shall post the following disclaimer on the respective UG social media site page: "The Unified Government of Wyandotte County and Kansas City, KS reserves the right to restrict or remove any postings or comments that violate the UG's Social Media Term of Use, which can be found on the UG website," or have linked on the page the Social Media Term of Use agreement.

Any content removed based on this Policy must be retained by the UG for a reasonable period of time, and will include the time, date and identity (including username or screenname) of the poster, when available.

The UG may ban specific users, but only to the extent that such users' comments are determined by the UG to repeatedly be in violation of the UG Social Media Term of Use. In no event shall a user be blocked for disagreeing with or providing a contrary opinion or point of view
