One new complaint was received by hotline call. Nine complaints are pending awaiting investigation or additional information. Five complaints were closed, four for no jurisdiction, one for lack of response. Seventeen advisory opinion requests are pending as of April 1, 2017. Four requests were closed, one with a written email advisory opinion provided, one with no formal opinion requested, two with no additional information provided. Three new email requests for an advisory opinion were received.

The one request for ethics presentation or training for a handicapped employee has been referred to Human Resources.

A presentation for the KU graduate class in public administration is scheduled for the Regents Center on April 4, 2017.
