# b). Monthly Administrator's Report:

If not a special session will be scheduled for them. A Continuing Ethics training is scheduled for March 16, 2016 at Human Resources.

Four new complaints were received. Ten complaints are pending awaiting investigation or additional information. Two complaints were closed with finding of lack of jurisdiction or insufficient information. Twenty five advisory opinion requests are pending as of the February 1, 2016. Eleven new email advisory opinions were requested as of February 1, 2015. Eleven advisory opinions were provided.

One request for ethics presentation or training for a handicapped employee is pending. A request for dates for UG Ethics Commissioner Continuing Ethics training is pending.

#### **New Business:**

Training for the new UG Ethics Commissioners will be held or scheduled or they are to attend one of the Basic Ethics classes for which dates were provided. The UG Ethics website has been updated with meeting minutes and agendas posted. The new UG Ethics Commissioners are still asked to review the biographical information posted that was taken from the press release and advise of any changes or corrections to the same.
