In-Person Motor Vehicle Services Paused Temporarily

All Motor Vehicle Services Can be Completed by Mail or Online

Due to COVID-19, Motor Vehicle Services at the Annex in Wyandotte County (8200 State Avenue) will temporally transition to online, drop off, and mail-only service. The transition to online, drop off, and mail-only service will begin November 2 and last through November 13.

Non-Treasury services at the Annex location are not affected and will remain open for in-person service.

All motor vehicle services can be completed online or by mail. To learn more, visit <u>wycokck.org/Auto</u> or reference the frequently asked questions below.

Motor Vehicle Frequently Asked Questions

1. What offices are open?

- a. The Downtown Office (710 N. 7th St., Suite 240) is open to the public exclusively for Real Estate, Personal Property Tax, and Treasury services.
- b. For all Motor Vehicle work not related to titles, the public is required to use our online, drop box, or mail-in options only.

2. Where is the drop box located? What can I use the drop box for?

- a. The Treasury Drop box is in front of the Annex Office public entrance at 8200 State Avenue.
- b. This process can be used to submit all Treasury related business processes that are not being serviced in office. This includes, but is not limited to, annual registration renewals, title work, lien releases, handicap placards, and real estate payments.

3. How do I register a new vehicle?

- a. The Treasury Office is offering several options to register a newly acquired vehicle without having to come into the office. This can be done by:
 - i. Completing the OpenForm located on our website at wycokck.org/auto and clicking on the link "Click here to initiate a request to title your recently purchased vehicle: Request a ugdmv-title."
 - ii. You will be prompted either mail in your title work to our Downtown Office (710

N. 7th St., Suite 240, Kansas City, KS 66101) or by the Treasury Drop Box located at the Annex Office (8200 State Ave., Kansas City, KS 66112).

4. How do I get a 60-day temporary tag?

5. How do I apply for or renew my handicap placard?

- a. These requests can be submitted to the Treasury Office by:
