**Per resolution, the Election Commissioner, Register of Deeds and Sheriff will receive COLA adjustments (not discrete steps) annually on January 1st based on memo from the Administrator's office. These classifications are paid equivalent to the non-union Director classification (Range 17).							
***The Administrative Judge is placed on Step 2; Step 1 is reserved for the non-Administrative Judge paid at 95% of the rate of the Administrative Judge.
