I. The Whole Person

The Whole Person helps their consumers to live independently in their homes by reimbursing caregivers to provide them with the supports they need to live on their own. Additionally, they provide employment services, rehabilitation services, youth transitional services, home modification assistance, recommendations and referrals for resources like food pantries, and Medicaid application assistance. Individuals that qualify for Medicaid are eligible for services provided by The Whole Person.

II. Wyandotte County Appraiser's Office

Wyandotte County Appraiser's Office explains that property value is determined by buyers' and sellers' decisions in the marketplace. The Appraiser's Office's role is to analyze transactions and appraise properties within the marketplace, and they have a legal responsibility to do so. Kansas State law requires that all properties are appraised at "fair market value." Property valuations are determined on January 1st, and notices of the current year's property values are sent out by March 9th (real estate) and May 1st (personal property). Valuation appeals are due on April 10th (real estate) and May 15th (personal property), but property owners have up to 30 days from the date they received their notice to file an appeal. The Appraiser's Office highly encourages property owners to file an appeal if they disagree with the valuation. Willard explains that this year's valuation changes were largely affected by the inflated costs that houses were selling for in 2022. Please, contact the Appraiser's Office if you'd like a representative from their office to speak with your neighborhood group.

Question: What criteria is used to determine a property's market value? Answer: Everything can have an impact—appraisers will look at lot size, improvement, housing condition, bedroom and bathroom count, etc.

Question: How can you tell the last time your home was manually reviewed? Answer: Call the appraiser's office or search your address on the UG's parcel database.

Question: How can I file an appeal? Answer: On the back of the appraisal notices there is an appeal form. You can also submit an appeal online.

Short-term rentals have been on the rise in the last few years due to the popularization of rental platforms like AirBNB, Home Away, etc. that allow property owners and private citizens to rent out their homes. Currently, special-use permits are used to address short-term rentals and distinguish between owner-occupied and non-owner-occupied properties. These short-term rentals are mostly concentrated in the Strawberry Hill and Rosedale neighborhoods. The department of Planning & Urban Design are working to update an ordinance that would balance short-term rental locations and buffer the effects that these rentals have on Wyandotte County neighborhoods. Farley states that special-use permits will soon be codified into county zoning codes which would then <u>require</u> short-term rental registration as opposed to <u>suggest</u>.

IV. Mayor's Office

The newly appointed County Administrator, David Johnston, begins their role on Monday, March 27th, 2023. Additionally, Medicaid re-enrollment letters are being delivered. If you or a relative receive Medicaid benefits, make sure to return the enrollment letter with most accurate, current details. The Clerk's Office is still processing Senior Tax Rebate applications but will conclude March 31st, 2023. In celebration of the closing of this tax season, City Hall will host a Senior Resource Fair on Friday, March 31st, 2023, from 9 AM to 12 PM. The Mayor's Office will also be hosting a STEAM Conference for high school students on April 22nd, 2023 at KCKCC—more information to come.

The platform's rules and guidelines are available there as well. There is an upcoming Listening & Learning Session on Saturday, April 22nd, 2023, at Central Office from 10AM to 12PM. ESER Funds were started during the COVID-19 pandemic to address the impact of COVID-19 on elementary and secondary schools. Lastly, Edwin mentions that KCK School Foundation for Excellence is launching a 2023 I Believe campaign which will offer grants for projects that pertain to community enrichment, professional development, etc. This campaign will run from April 1st to April 30th, 2023. Additionally, MarkI adds that registration for the Summer Learning program is still open but will close April 21st, 2023. Kindergarten registration for the 2023-2024 school year is now open.

The DA's Office warns the public about the dangers of fentanyl and that overdoses of this drug are a very serious issue, not only in Wyandotte County but across the nation. In Wyandotte County, there has been a total of 42 fentanyl overdoses, 5 of which were overdoses of minor, and 6 resulting in death this year.

Short-term rental ordinance approval process will take place in April. Regarding updates on "request for qualifications" on 3 unified government-owned landbank properties, there was a bidding seminar that took place March 23rd, 2023 that gathered prospect lead developers, sub-consultants, and contractors interested in developing these 3 properties. The landbank policy is in the process of being updated, and a subcommittee meeting regarding this policy took place March 23rd, 2023. Unified Government is developing a city-wide comprehensive plan—topics of discussions are neighborhood business revitalization organizations (NBRs), public safety. Utilities, land use, housing, historic preservation, etc. These summits and discussions will take place over the next year.
