### • Jack Webb:

a) Update CDBG Project City Park – Project is currently delayed. The restroom is being built and will be in by the end of July and the project should start back up after

- that, including the road being done.
- b) Update Small Pavilion at City Park This project is complete.
- c) Current Budget Cuts— \$335,000.00 has been cut so far and they do not have information to present at this time.
- d) Inclusive Playground at the WYCO Park/Bonner Currently working on this project, there were some delays on equipment shipping from overseas, but the project should be completed by the next Park Board Meeting.

### Angel Obert:

- a) Parkwood Pool/Spray Parks It was decided by the County Commissioners to remain closed for the 2020 season due to the COVID19 Pandemic.
- b) Summer Program It was decided by the County Commissioners to cancel these programs due to the COVID19 Pandemic.
- c) Youth Sports It was decided by the County Commissioners to cancel all youth sports activities due to the COVID19 Pandemic.

### BOARD MEMBER'S QUESTIONS OR COMMENT

- Carolyn Wyatt questioned Jeff Sachen running the meeting, and the process of which the vote was taken. She also inquired about the budget being cut and where those funds would be going since they are cutting the funds. Jack explained that with the budget cuts there would be no funding for projects in the centers.
- Faith Rivera Requested a meeting with someone from the Parks Department regarding the budget. Stated that we would send her a copy of the budget that was originally set for this year. Stated that she is excited to be on the WYCO Park Board.
- Pat Gates Stated that the Commission had been in meetings regarding budget cuts and the lack of funds in the county due to the Pandemic.
- Tammy Romstad Asked how other surrounding Parks and Recreation departments are handling programing. Angel stated that all surrounding counties are all following the same guidelines. Would like to be apart of any help on getting more funding for the Parks & Recreation Department.
- Billy Brame Asked if there were going to be more budget cuts or if what Jack stated would be the total cut. Jack stated that at this time there would more than likely be more cuts but nothing had happened yet.
- Jeff Sachen Asked if Christmas in July would still go on. Jack stated that he is expecting it to be canceled.
