DIRECTOR'S REPORT:

Leavenworth:

➤ Connie Harmon announced the Leavenworth Council on Aging (LCOA) currently have an open position available for the Leisure & Learning Coordinator. They have received an

overwhelming response for that position.

➤ Connie shared that the LCOA is currently sending surveys to its constituents. The surveys are designed to see if current programs are still of interest and gain insight to any new program interests. The survey also asks if seniors are still wanting "contactless" meal delivery.

Wyandotte:

- Ruth Jones stated that Wyandotte County is attempting to revamp hot meals in our area. In September 2019, Wyandotte County lost its hot meal provider and has since been serving chilled or frozen meals. Wyandotte County is currently working with the Unified Government Transit office to deliver a limited number of hot meals.
- ➤ Ruth announced that the WyCo AAA is planning to open a new Congregate Meal Site at Victory Hills Church. The church is located at about 66th & Parallel Pkwy.
- ➤ Ruth mentioned that the Vernon Senior Center is moving toward a re-opening of its meal site and in-person senior activities.

- > Linda Ramirez announced that there has been a new advisory council member, Pam Blood. Ms Blood was appointed by Commissioner McKiernan.
- ➤ Linda also congratulated Mr. Gordon on being elected as the 2nd Vice Chair for the Silver Haired Legislature.
