DIRECTOR'S REPORT:

Leavenworth:

➤ Connie reported that the Leavenworth Council on Aging (LCOA) received 7 new fleet vehicles in the last month. These vehicles were ordered in 2020 and are now just coming in.

➤ The staff at the LCOA has been working diligently to complete the Older Americans Act revision for 2022 grant year, as well as the 2023 year. Both have been submitted for approval.

- ➤ The LCOA Human Services staff are working on a plan for Falls Prevention Awareness Week (Sept 18-24). In conjunction with the University of St. Mary's occupational and physical therapy students, the campaign will raise awareness about how to prevent falls and fall related injuries. The free event will provide education and screening opportunities.
- The LCOA are hosting a Brunch and Learn event, Treatment Options for Low Back Pain. The event will be held on September 16, 10am at the Leavenworth Council on Aging.
- ➤ Three SHICK (Senior Health Insurance Counselors for Kansas) counselors will attend a full day of training on Medicare changes in August and September. Medicare Open Enrollment begins Octo 7th.
- Connie also mentioned that the LCOA will be moving in October and that they are super excited.

- The Area Agency on Aging will be hosting an upcoming "Digital Literacy & Inclusion for Older Adults" The free event will provide training to the public on various information such as cybersecurity, how to protect your personal information, internet browsing options and how to utilize a tablet. Participants will be served lunch and may be eligible to receive internet service for \$10 per month.
- ➤ The Area Agency on Aging escorted a group of 20 seniors to Union Station on August 18th. The seniors visited the Extreme Screen Theater, enjoyed a boxed lunch from Grandmas Catering and viewed the constellations in the Planetarium. The scheduled Maya Exhibit was unavailable that day, but seniors were given tickets to attend the exhibit on their own.
