CALL TO ORDER: Jamey Rodriguez called the meeting to order at 10:04am.

COMMENTS: Jamey Rodriguez stated that she attended the Older Americans

Month Celebration and that it was nice considering the circumstances and not having the event in 2 years. She is looking forward to the Monarch's baseball game with the

DIRECTOR'S REPORT:

Leavenworth:

Jessica Pontbriant provided the Director's for Connie Harmon.

- > The Leavenworth Council on Aging hosted their *Indoor*Senior Picnic in recognition of Older Americans Month on
 Friday, May 13th at the Eagles Lodge. Over 150 people
 attended the event and feedback received was very positive.
- All Leavenworth County Congregate Meals Sites will be fully open on June 1st and offer in-person dining as well as grab-n-go lunch options.

- > The Farmer's Market Voucher Program will begin on June 1st and all staff involved with the program have received training.
- The Human Service team is planning activities for World Elder Abuse Awareness Day(WEAAD). The County Commissioners will read a proclamation declaring June 15th WEAAD in the County. Staff will host a Lunch & Learn with St. John's Hospital. A social worker from the Senior Behavior Health Center will offer a presentation on senior safety.
- ➤ Staff recently completed interviews with Meals on Wheels of America for a research study they are doing about pet programs. The LCOA Pet Program team has been mentoring three other AAAs in Kansas and Wyoming as they begin their pet programs. Staff also applied for \$15000 grant through Meals on Wheels of America to provide additional veterinary services.

Wyandotte:

Linda Ramirez provided the Director's report.

- ➤ Linda reported that a wait list remains active for the Seniors Care Act (SCA), Older Americans Act Title III-B (OAA) and Senior Services Program (SSP). The Area Agency on Aging received an additional \$275,000 in SCA dollars from the Kansas Department for Aging & Disability Services. That funding will keep current customers active through June 30. The new award for SCA will begin July 1.
- ➤ The Caregiver Support Program is launching its *Cardio Not Carbs for the Caregiver* project combining exercise, healthy eating, and a support group into one class. Linda Ramirez will share a flyer of this information.
- ➤ The Wyandotte County AAA office will be offering respite for grandparents who are tasked with being the primary caregiver for their grandchildren. Although the day activity has not been revealed. Grandparents 55 & over, living in Wyandotte County should contact the AAA to provide their interest for this program.
- ➤ The Area Agency on Aging has applied for some of the Unified Government ARPA funds. Deadline to apply is June 22nd. Services that the AAA intends to utilize funds for include Emergency Assistance, Energy Assistance,

Homemaker Services, Attendant and/or Personal Care Services, Internet and Telephone Assistance, and internet Service for the 8 congregate meal sites.

- The Callgivers Program is available for isolated seniors in Wyandotte County. Callgivers offer a friendly call to seniors, and functions as a wellness support check for seniors in our community. Linda Ramirez will distribute flyers to board members.
- ➤ Funding is still available for the Battling Isolation Program which will assist with a one-time payment for internet/phone service. The funding is to be used for those who are attempting to stay connected to seniors or for those seniors in need of assistance paying their bill.
- ➤ Due to the cyberattack, our fiscal department is 2 months behind in financial reporting to the Kansas Department on Aging & Disability Services. However, we are now allowed access to the financial system to pay invoices. Once the AAA is caught up on all payments, updated reports will be available in the coming weeks.

OTHER BUSINESS:

- ➤ Linda Ramirez reported that the Area Agency on Aging has several vacancies on the areawide advisory council. If you know anyone interested in serving on the board, have them contact Linda Ramirez for instruction.
- ➤ Linda Ramirez reported that the Silver Haired Legislature will be meeting in our office on June 8th at 10:30am. The SHL will discuss the issues brought forward from public input. Linda suggested contacting your SHL member to give feedback that you would like to take to the Executive Board meeting in October.

- Be prepared to submit a copy of the outstanding bill identifying the amount past due and include the current amount due.
- Provide the name of the carrier to whom the payment is owed, along with the account # and mailing address for payment.
