DIRECTOR'S REPORT:

Leavenworth:

- ➤ Connie Harmon announced that the Council on Aging will be hosting Senior Day at the Leavenworth County Fair. They expect over 200 attendees despite the anticipated heat. Daysia Rennau, former *The Voice* contestant and Leavenworth County native is scheduled as entertainment.
- ➤ The Council on Aging has hired three new staff and facilitated one inter-office transfer due to retirements and resignations.

- On July 17th, the Council on Aging partnered with the University of St. Mary Physical and Occupational students to offer senior health fitness assessment. Appointments were scheduled in 10-minute intervals and participants left with detailed assessment information and steps to reach fitness goals.
- ➤ The Council on Aging Annual Poker Run was held on July 15th in collaboration with *The Escorts Motorcycle Club*. The fundraiser benefits the Senior Express Transportation Program.
- ➤ The LCOA has relaunched their intergenerational program and had a good turnout for their first outdoor "play day." Their next event is a Splash Day on August 3rd and will be held at Hawthorn Park Splash Pad.
- ➤ The Bucket List Adventure Series Trips (BLAST) will continue with a "Take the Stage" event at 424 Lounge in Leavenworth and a kayaking trip at Lake Perry on August 28th.

Wyandotte:

Linda Ramirez provided the Director's report.

- ➤ Linda shared that the In-Person Assessments are in full affect. Wyandotte County began May 11, 2023. All assessments and re-assessments are now done face-to-face in the customer's home.
- ➤ Linda announced that a Public Hearing/Town Hall meeting will be held on August 1st, 10am 12pm at Victory Hills Baptist Church. Several Kansas Legislators and Unified Government Commissioners are expected to be in attendance.
- ➤ Linda shared a video created by the Unified Government's Strategic Communications Department as it regards to the Grandparent Support Program funded under the Title III-E Caregiver funds. In the video, Dress for Success recipients were featured. The grandparent support program is gearing up for the 2023-24 school season and interested grandparents should contact Linda Ramirez.

- ➤ The Wyandotte County office currently has 3 SHICK (Senior Health Insurance Counseling for Kansans) counselors trained and ready the upcoming Medicare Open Enrollment period (October 15-December 7th).
- ➤ Linda announced that the Wyandotte County AAA will be taking a group of 20 seniors to the New Theatre & Restaurant on September 6th to see the musical Dreamgirls. Tickets will cost the senior \$25 and will include lunch, show ticket and transportation.
