



From CHA to CHIP



Our journey towards the 2024-2028 Community Health Improvement Plan (CHIP), began with the Community Health Assessment (CHA), which was conducted in 2022. This timeline provides an overview of the process that led to the 2024-2028 CHIP. It illustrates the community engagement that took place to inform both the CHA and the goals and strategies in the CHIP.

DATA COLLECTION THROUGH THE COMMUNITY HEALTH ASSESSMENT

June 2022

Community Concerns Survey Mailed to Households

The CHA concerns survey included questions from a range of health topics. A total of 1,150 community members responded to the survey. This sample was representative of Wyandotte County zip codes, age groups, income, education and race.

August-October 2022 CHA Focus Groups and Community Forums Completed

The Wyandotte County Public Health Department (WYCO PHD), with assistance from community partners, hosted 14 focus groups, five community forums and one virtual forum, to hear directly from community members about their perspectives on community health.

October 2022 Local Public Health Assessment Completed

A total of 141 community partners attended the event to discuss the Local Public Health System in Wyandotte County, representing 75 different organizations.

November 2022-March 2023 **Data Analysis**

The WYCO PHD analyzed all data collected through the CHA process.

IDENTIFYING CHIP PRIORITIES

May 2023 CHA Community Event

Over 60 community stakeholders attended the CHA event to hear about the findings, interact with the data and discuss how the information from the CHA informs the CHIP.

May-August 2023 CHA Health Issues Prioritization

The health issues identified in the CHA inform the health priorities addressed through the CHIP. The WYCO PHD created a prioritization survey, distributed at over 15 community presentations, to collect input from stakeholders (96 respondents) on the top health issues identified in the CHA.

August 2023 CHIP Steering Committee Adoption of 2024-2028 CHIP Priorities

The CHIP Steering Committee provides overall guidance and strategic oversight to the CHIP. They reviewed and adopted the following five 2024-2028 CHIP priority areas and reaffirmed the three CHIP "Lenses" of poverty, racism and trauma:

FROM PRIORITIES TO PLANNING

October 2023 2024-2028 CHIP Planning Process Kickoff Event

Kicked-off the 2024-2028 CHIP planning process with an event to celebrate past successes during the 2018-2023 CHIP and introduce the new health priorities. A total of 103 community stakeholders were in attendance to contribute to our community's shared vision for health improvement.

October-November 2023 CHIP Priority Area Planning Sessions, Series 1 and 2

A total of 287 people participated in a series of 10 planning sessions to inform the development of strategies and objectives for each of the five priority areas, two sessions were held per health area (series 1 & 2).

During series 1, participants identified "Focus Areas", or the specific ways in which the community will collaboratively address the priority areas (i.e., for Jobs and Education, increasing fair chance hiring was identified as an area of focus). During series 2, participants brainstormed strategies and objectives.

FROM PLANNING TO ACTION

December 2023-April 2024 Finalize CHIP & Identify Lead Agencies

The "Lead Agencies" are community organizations with expertise in each of the CHIP priorities, they work closely with the WYCO PHD to coordinate the CHIP Action Teams and provide leadership to implement the plan's strategies.

May 2024 2024-2028 CHIP Published

May 2024-December 2028 Implement CHIP
